This will confirm the information furnished  
February 4, 1969, to [redacted] of your office.

A source of this Bureau who has furnished  
reliable information in the past advised that Mrs. Coretta  
King, widow of the late Martin Luther King, Jr., planned  
to call the President to discuss with him a proposed  
memorial center commemorating Martin Luther King, Jr.

Stanley David Levison, an advisor to Mrs. King,  
has suggested that Mrs. King would not want to place herself  
under any obligation by asking the President for help but  
suggested that she take the approach that it is not a question  
of asking the President for a favor but rather that the  
Federal Government owes it to the Negro to establish such a  
memorial.
